Background:

The Pacific Community has received financing in the amount of USD 4.5 million equivalent from the World Bank toward the cost of the Statistical Innovation and Capacity Building in the Pacific Islands Project, and it intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include those of a Microdata Anonymization Consultant over the period of February to November 2024. The Consultant will be home-based, and the required services relate to census and survey microdata anonymization methodologies in the Pacific region. The assignment requires stakeholder consultation, methodology and literature review, making a presentation to stakeholders and the preparation of a report and a policy brief/guidance note. Any travel required under these consulting services will be organized by SPC or by the consultant, in accordance with SPC's travel policy requirements. SPC doesn't cover cost related to visa and medical insurance for consultants.

The overall objective of the assignment is to provide information to the Pacific Statistics Methods Board (PSMB) and other Pacific statistics decision makers to guide decision making in relation to anonymization methods, with particular focus on Household Income and Expenditure Survey (HIES) data.

The consultant will:

- i. Review current anonymization methods adopted by SPC and Pacific Island Countries and Territories (PICTs).
- ii. Document recommended best practice for anonymizing HIES, and other survey and census microdata.
- iii. Provide a guidance note.

The detailed Terms of Reference (TOR) for the assignment is appended herewith.

The Pacific Community now invites eligible individuals ("Consultants") to indicate their interest in providing the Services.

Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (attach curriculum vitae with description of experience in similar assignments, similar conditions, etc.).

Terms of reference for the "Methodological review for anonymising census and survey microdata in the context of Small Island Developing States".

Background information on the project

The Pacific Community

The Pacific Community (SPC) (<u>www.spc.int</u>) is the principal scientific and technical organization supporting development in the Pacific region. It is an international organization established by treaty (the Canberra Agreement) in 1947 and is owned and governed by its 27 members, including all 22 Pacific Island countries and territories (PICTs). SPC's headquarters are in Noumea, New Caledonia, and it is one of nine member agencies of the Council of Regional Organizations of the Pacific (CROP).

The Statistics for Development Division

The Statistics for Development Division (SDD) (http://sdd.spc.int) of SPC is the main stakeholder in the implementation of the Ten-Year Pacific Statistics Strategy (TYPSS), which was adopted by PICT leaders in 2009 in recognition of the need for a comprehensive plan to drive improvement and development of statistics in the Pacific region. TYPSS proposed a regional approach to provide regional strategic leadership to improve the scope and quality of national statistics. The ten-year strategy (2010 - 2020) outlined a series of short and long-term programs to contribute to national statistics capacity development and regional coordination and capability. SDD's strategic framework is guided by TYPSS and its current work program by the Business Plan 2018 - 2020. The revision of both TYPSS and SDD's business plan are currently underway.

SDD plays a significant role for TYPSS as a large and comprehensive technical provider to national statistics offices (NSOs) in the Pacific region. SDD's technical assistance role has been strongly endorsed by NSOs, in particular the Small Islands Developing States (SIDS) where resources are limited, and technical assistance and supplementation is essential. As part of a regional organization with a broad technical and social mandate operating across 22 PICTs, SDD has been able to translate and mediate between international standards and frameworks and Pacific contexts and focus.

Statistical Innovation and Capacity Building in the Pacific (PACSTAT) Project

The <u>PACSTAT project</u> is an International Development Association (IDA) funded project to be implemented over the period of June 2020 to December 2025. The overall development objective of PACSTAT is to improve the quality of welfare data collection and accessibility to comparable welfare data in the Pacific Island Countries.

The context for this project is that PICTs are characterised as having small populations that live across vast areas of the Pacific. More comparable data is needed to understand deprivation in PICTs overtime, and between countries to monitor regional trends. The Pacific is a region with substantial gender inequality and data deprivation hinders evidence-based policy. Public access to data is another challenge facing the region and data deprivation hinders efforts to track and monitor progress on reducing poverty and inequality, and to implement policy.

National Statistics Offices (NSOs) in the Pacific region lack funding to meet the costs of data collection, and the small populations are of low statistical capacity in terms of budget, labour qualification, and other technical constraints associated with technology and statistics across the vast Pacific.

The Pacific Statistics Methods Board (PSMB; https://sdd.spc.int/pacific-statistics-methods-board-psmb) has potential to accelerate the adoption of new methods for data collection and statistical analysis as well as promote regional harmonization and comparability.

The Project includes the following components and sub-components:

- i. To support the administration of PSMB and the dissemination of its recommendations:
 - a. PSMB technical support and administration, including overseeing PSMB commissioned statistical development research, such as the activities of this Terms of Reference;
 - b. Dissemination and training of best practice recommendations from the PSMB to regional NSOs, such as the activities of this Terms of Reference; and
 - c. Improve the analysis and publication of gender statistics in the region.
- ii. To strengthen SPC-SDD's ability to play a "statistical system leader" role and provide technical assistance on data collection methods:
 - a. Expanding technical capacity of SPC-SDD in welfare data collection, analysis, and dissemination;
 - b. Create comparable indicators, including gender statistics, and micro-datasets to promote data use in the region.
- iii. To promote context-appropriate innovation in the Pacific region and experimentation in statistical methods.

Data use in the Pacific region

In lieu of population-based registers, the Pacific region depends significantly on data produced through the suite of core national statistical collections for population-based social and economic statistics. The core suite of statistical collections - including: i) Population and Housing Census (PHC), ii) Multiple Indicator Cluster Survey (MICS) programme with possible integration of modules typically included in Demographic Health Survey (DHS), iii) Household Income and Expenditure Survey (HIES), iv) Labour Force Survey (LFS), v) Agricultural Census / Survey, and vi) Disability Survey - collectively contribute data towards populating around half (63 of the 132) of the Pacific subset of SDG indicators and 87 percent of the population-based indicators. The coverage of the core national statistical collections presents endless opportunity for thematic analysis and research for policy development across a wide range of sectors and cross-cutting issues, including gender.

Numerous nationally representative census and surveys (https://sdd.spc.int/census-and-survey-calendar) have been conducted in the Pacific region; however, data remain mostly underutilised. In many cases, upon completion of the census/survey report, the microdata sets are not made available for further use. This is a missed opportunity for the economic and social development of the Pacific region and hinders evidence-based policy derivation and monitoring.

There are numerous factors as to why data are not made available for secondary analysis, which range from unclear mandate in statistics legislation in relation to microdata dissemination, to data sovereignty, capacity limitations, and **risk of individual disclosure**.

This assignment aims to explore matters relating to anonymising Pacific development microdata, including identifying the costs and benefits of microdata anonymisation, and other related matters, such as the main principles of microdata anonymisation and anonymisation techniques.

Objectives of the assignment

The overall objective of the assignment is to provide information to help the Pacific Statistics Methods Board (PSMB), and other Pacific statistics decision makers, with information to guide decision making in relation to the methodology for anonymization of census and survey microdata.

This Consultancy will research multiple aspects relating to anonymization of microdata (or unit record data) sourced from population-based censuses and household surveys, however with particular focus on HIES data. The overall objective is to disseminate best practice recommendations from the PSMB to regional statistics stakeholders, and to provide strengthen capacity in the region with respect to microdata anonymisation.

This specific research aims to make recommendations to PSMB in relation to technical matters associated with microdata anonymization, and to synthesise recommendation and policy implication in a policy brief for statistics decision makers. The objectives are therefore to:

- i. Consult stakeholders and undertake literature review to understand, evaluate and critique the current procedures and protocols in place in the Pacific Region in relation to survey and census microdata anonymization, with a focus on Pacific countries NSOs, other organisations operating in the Pacific region (such as the World Bank, UNICEF, WHO, Australian Bureau of Statistics (ABS) and Stats New Zealand) and SPC's Pacific Data Hub Microdata Library.
- ii. Document recommended best practices for anonymising household surveys and census microdata, with a particular focus on:
 - a. Techniques to measure disclosure risk (individual vs. global measures);
 - b. Methods to reduce disclosure risk (including those based on data reduction, such as top and bottom coding, and those based on data perturbation, such as data swapping, adding noise);
 - c. Methods for assessing the resulting information loss (bias, impact on variance of estimates, impact on regression coefficients and statistical analyses...).
- iii. Prepare a guidance note and a policy brief including recommendations, policy implications and critical pathway to improve microdata anonymization methods in the Pacific Region to support Pacific statistics stakeholders to make decisions in relation to microdata anonymisation as well as the pros and cons of microdata anonymisation with respect to maintain 'usability' of the microdata for small populations and specific purposes, including poverty mapping.

Scope of work and description of tasks

The assignment is to be performed across data sourced from household and population-based surveys, including HIES, MICS (UNICEF), DHS and STEPS (WHO), Agriculture, Labour and Disability surveys, and relating to some aspects of census anonymisation, with a main focus on anonymising HIES microdata sets.

The Scope of the assignment includes:

- i. Stakeholder consultations.
- ii. Literature and methodological reviews.
- iii. Drafting one report and a policy brief for consultation with PSMB and other stakeholders.
- iv. Participation to two consecutive meetings of the Pacific Statistics Methods Board (PSMB);
- v. Preparation of a 'publication ready' final draft of the report and the policy brief.

Consultation with stakeholders

Stakeholders are defined as members of PSMB as well as SDD Staff and other project Consultants. As the need arises, other stakeholders, such as Government Statisticians and technical partners, such as the World Bank, will be engaged.

Around 5-days should be dedicated to consulting with Stakeholders. Attending the PSMB meeting in Brisbane from 10 to 11 May 2023 is essential (either virtually or physically) and there may be a need for some virtual meetings with PSMB throughout the assignment. Consultations with other stakeholders, such as Government Statistician, World Bank, SDD, and others identified, will consist of a series of virtual meetings. There will be ongoing dialogue with the Project Manager and other SDD staff. The purpose of consultations is to evaluate the current situation in terms of microdata anonymisation in the Pacific, and to identify anonymization challenges.

The Project's <u>Stakeholder Engagement Plan</u> is to be implemented throughout the assignment with all stakeholders to be made aware of the Project grievance mechanism and provided with contact information to lodge grievances, as follows:

Report: Statistical techniques to anonymise Pacific surveys microdata

The objective of this report is to serve as an information reference for Pacific statistics decision makers, and as the basis for producing the Policy Brief. The report will support decision making and policy on microdata anonymisation, with an overview of the current situation in the Pacific countries, the methodologies to evaluate disclosure risk, the statistical techniques for reducing such risk and the methods to estimate the subsequent information loss. The focus is on issues relevant to HIES microdata, with implications for data use in poverty, food security, labour, and gender analyses. Identifying issues that are common to SIDS is also of interest.

The report will be published by SPC; it is expected to be a high-quality product digestible by Pacific statistics technicians. An example of the content of the report is provided below:

- i. Introduction to microdata anonymisation: main principles and dictionary of definitions (de-identification, risk of individual disclosure, recoding, post-randomization, shuffling, etc.).
- ii. Literature review and synthesis in relation to the benefits, costs and risks associated with microdata anonymisation; specific challenges in the case of SIDS and HIES; methodological review of different approaches to anonymizing survey microdata, with particular focus on household income and expenditure surveys, and methods to measure and reduce disclosure risk and for estimating the resulting information loss.
- iii. Documentation and critique of the current processes and protocols of the Pacific Data Hub Microdata Library, including current anonymization process, and those of other organisations, such as World Bank, UNICEF, the DHS Programme, WHO, ABS and Stats-NZ. Case studies of best practice.
- iv. Policy implication, critical pathway, and recommendation for anonymising microdata in the Pacific.

Policy brief

The report is to be accompanied by a policy brief that clearly presents the risks, opportunities, and costs of anonymizing microdata in the Pacific. The policy brief should be around 2- to 4-page long and should be written for a non-technical audience, with graphics welcomed.

Expected outcomes, deliverables, and timeline.

The Project Development Objective is to improve the quality of welfare data collection and accessibility to comparable welfare data in the Pacific Island Countries.
